CYFLWYNIAID INTRODUCTION

Mae Brenig Wind Limited yn ardal Cyngor Cymuned Nantglyn a ward etholiadol Llanrhaeadr yng Nghinmeirch yng Nghyngor Sir Ddinbych.

Mae Brenig Wind Ltd yn cynnig cronfa budd cymunedol gwerth bron i £4 miliwn dros gyfnod o 25 mlynedd ac erbyn hyn mae modd i gymunedau yn nalgylch Brenig fanteisio ar y gronfa. Fe gafodd y fferm wynt, y mae Brenig Wind Limited yn berchen arni, ei sefydlu ym mis Mawrth 2019 a chanddi 16 tyrbin i gyd. Mae pob un o'r tyrbinau'n cynhyrchu 2.35MW sy'n golygu bod cyfanswm yr ynni gaiff ei gynhyrchu'n 37.6MW. Mae hyn yn ddigon i gynnal dros 30,000 o gartrefi pob blwyddyn. Fe gaiff y gronfa ei dosbarthu rhwng prosiectau a mentrau cymunedol yn yr ardal.

Yn 2018, fe gafodd Cadwyn Clwyd eu penodi gan Brenig Wind Ltd fel gweinyddwr y gronfa. Mae Cadwyn Clwyd yn Asiantaeth Datblygu Gwledig sy'n gyfrifol dros reoli a chynnal prosiectau, cynnig cefnogaeth ymarferol a chyllid grant er mwyn datblygu ac arallgyfeirio'r economi yng Ngogledd Ddwyrain Cymru drwy gyllid sector cyhoeddus, sector preifat a'r trydydd sector. Mae Cadwyn Clwyd yn gweithredu ers 25 mlynedd ac mae wedi hen ennill ei blwyf fel asiantaeth sy'n cefnogi, ariannu a datblygu prosiectau yn yr ardal. Bu i Cadwyn Clwyd gyflwyno dros £30miliwn i gymunedau'n uniongyrchol er mwyneu cefnogi gyda sectorau megis:

Brenig Wind Limited is located in the Community Council area of Nantglyn and the electoral ward of Llanrhaeadr yng Nghinmeirch within Denbighshire County Council.

Brenig Wind Ltd provides a community benefit fund of almost £4 million over 25 years is now available for communities surrounding the Brenig site. The windfarm owned by Brenig Wind Limited became operational in March 2019 and has 16 turbines each of 2.35MW, giving a total installed capacity of 37.6MW – enough to power over 30,000 homes every year. The fund is to be distributed to local community projects and initiatives.

In 2018, Cadwyn Clwyd was appointed by Brenig Wind Ltd as administrator of the fund. Cadwyn Clwyd is a Rural Development Agency, which provides project management and delivery, hands on support and grant funding to develop and diversify the economy in North East Wales through public, private and third sector funding. It is firmly established as a supporter, funder and deliverer of projects in the area having been operational for 25 years, directly delivering over £30million of support to communities within sectors such as: Diversification of Agriculture, Agri-Food & Speciality Foods, Environmental Schemes, Community Renewable Energy, Cultural Tourism, Green Tourism, Heritage and Conservation Projects, Social Enterprise Development, Community Development, Community Capacity Building, Access to Services and Skills & Training.

Arallgyfeirio Amaethyddol, Bwydydd Amaethyddol a Bwydydd Arbenigol, Cynlluniau Amgylcheddol, Ynni Adnewyddadwy Cymunedol, Twristiaeth Ddiwylliannol, Twristiaeth Werdd, Prosiectau Treftadaeth a Chadwraeth, Datblygu Mentrau Cymdeithasol, Datblygu Cymunedol, Adeiladu Galluoedd Cymunedol, Mynediad i Wasanaethau a Sgiliau a Hyfforddiant.

Mae cronfa Brenig yn cynnig cyfanswm o £150,000 y flwyddyn wedi'i fynegrifio dros gyfnod o 25 mlynedd ar gyfer cynnal a gweinyddu'r gronfa budd cymunedol. Yn ystod y cyfnod cofnodi cyfredol, fe gafodd tair rownd cyllid eu lansio gyda grantiau gwerth £270,000 ar gael. Mae'r cyllid wedi'i glustnodi ar gyfer 2019 a 2020.

The Brenig fund provides a total of £150,000 per annum index linked over 25 years for the community benefit fund including its administration. During the current reporting period, three rounds of funding were launched with a total of £270,000 grants available, this constitutes funds for 2019 and 2020.

BRENIG WIND LTD GRANTS PANEL AND CADWYN CLWYD ADMINISTRATION

Mae Panel Grantiau yn gyfrifol am oruchwyllo gweinyddiaeth Cronfa Budd Cymunedol Brenig Wind Ltd ac ymysg aelodau'r Panel mae unigolion sy'n byw, gweithio neu wirfoddoli yn yr ardal. Mae'r panel yn gweithredu gan gydymffurfio gyda chylch gorchwyl y cytunwyd arno ac maen nhw'n cyfarfod o leiaf dwywaith y flwyddyn er mwyn asesu ceisiadau grant a chynnig argymhellion i Brenig Wind Ltd o ran pa brosiect ddylen nhw ei gefnogi. Yn ystod y 12 mis diwethaf, bu i'r panel gyfarfod deir gwaith er mwyn asesu'r tair rownd o geisiadau cyllid.

Aeth Cadwyn Clwyd ati i ffurfio'r panel ym mis Hydref 2018 yn dilyn anfon gwahoddiad agored am unigolion â diddordeb ar sail manyleb person. Mae 8 aelod ar y panel i gyd. Mae 2 ohonyн nhw'n gynrychiolwyr o awdurdodau lleol gafodd eu penodi'n dilyn gwahoddiad gan Cadwyn Clwyd ac fe gafodd y 6 aelod sy'n weddill eu dewis o bobl sy'n byw, gweithio neu wirfoddoli yn yr ardal sy'n elwa. Cafodd 38 cais eu cyflwyno ac aeth Cadwyn Clwyd a'r ddau gynrychiolydd o'r awdurdodau lleol ati i ddwyn i ystyriaeth y ceisiadau. Mae gan y panel amrywiaeth o unigolion grymus sydd wedi'u greiddio'n gadarn yn yr ardal ac sy'n ymroi i ofalu bod yr ardal yn ffynnu.

Cafodd dwy swyddog Cadwyn Clwyd eu penodi i gynnal y gronfa, Lowri Owain Rheolwr y Cwmni a Helen Williams Swyddog Menterau Cymdeithasol gyda chefnogaeth gan y Rheolwr Cyllid, Delyth Edwards a'r Swyddog Busnes a Chyfathrebu, Donna Hughes.

Mae cydweithio yn rhan annatod o ethos Cadwyn Clwyd ac fel y cyfryw mae dau swyddog awdurdod lleol yn cydweithio gyda swyddogion Cadwyn Clwyd i gynnig cefnogaeth barhaus i gymunedau a grwpiau. Y cynrychiolwyr hynny ydy Fran Rhodes sy'n Swyddog Datblygu Cymunedol yng Nghyngor Sir Ddinbych ac Ela Williams sy'n Swyddog Cymuned, Diwylliant a Threftadaeth yng Nghyngor Bwrdeistref Sirol Conwy.



The Brenig Wind Ltd Community Benefit Fund administration is overseen by a Grants Panel of individuals living, working, or volunteering in the area. The panel operates under an agreed terms of reference and meets a minimum of twice a year to assess grant applications and make recommendations to Brenig Wind Ltd as to which projects should be supported. During the last 12 months, the panel has met three times, to assess the three rounds of funding applications.

Cadwyn Clwyd formed the panel in October 2018 following an open invitation from interested individuals based on a person specification. The panel comprises of 8 members, 2 local authority representatives were appointed following an invitation from Cadwyn Clwyd to each local authority, the 6 remaining spaces were drawn from people who live, work or volunteer in the area of benefit. 38 applications were received and appraised by Cadwyn Clwyd and the two local authority representatives. The panel has a cross section of dynamic individuals who are firmly rooted in the area and are committed to making the best for the area.

The fund has two Cadwyn Clwyd officers assigned to its delivery, Lowri Owain Company Manger and Helen Williams Community Enterprise Officer, with support from the Finance Manager Delyth Edwards and Business and Communications Officer, Donna Hughes.

Cadwyn Clwyd's ethos is firmly rooted on partnership working, and as such has two local authority officers working alongside Cadwyn Clwyd officers to provide ongoing support to communities and groups. These are Fran Rhodes, Community Development Officer at Denbighshire County Council and Ela Williams, Community, Culture & Heritage Officer at Conwy County Borough Council.

PANEL GRANTIAU

GRANTS PANEL

LLYR JONES - Cadeirydd

Mae Llyr yn byw ar fferm Derwydd a bu'n ffermio yno ers 1999. Mae ganddo ddiadell bersonol o 1100 o ddefaid ynghyd ag uned wyau buarth sy'n gartref i 16,000 o ieir. Mae Llyr hefyd yn gydberchennog ar Blodyn Aur, cwmni olew had rŵp Cymraeg sy'n gwerthu oddeutu 6000 potel y mis i fasnachwyr bwyd bach ledled Cymru ac i archfarchnadoedd hefyd. Yn dilyn y deddfau stoc marw newydd yn 2005, bu i Llyr arwain grŵp o 10 o ffermwyr yr ardal gan sefydlu'r llosgydd cydweithredol di-elw cyntaf o'i fath. Mae Llyr yn dal yn ysgrifennydd ar y cwmni hyd heddiw ac yn ddiweddar bu iddo gymryd yr awenau fel trysorydd hefyd.

LLYR JONES - Chairman

Llyr lives at Derwydd farm where he has been farming since 1999. Llyr runs a closed flock of 1100 ewes together with a 16,000 hen free range egg unit. He is also co-owner of Blodyn Aur, a Welsh rapeseed oil company which sells around 6,000 bottles per month to small food retailers throughout Wales and to the supermarkets. Following the introduction of new fallen stock laws in 2005, Llyr led a group of 10 local farmers and started the first non-profit, cooperative incinerator for which he is still company secretary and more recently took over the role of treasurer. The company now provides around 90 farmers with a cost-effective solution to

PRYS ELLIS

Mae Prys yn aelod o Gyngor Cymuned Cerrigydudion ers dros chwarter canrif ac wedi bod yn gadeirydd y Cyngor Cymuned ar sawl achlysur. Mae hefyd yn cynrychioli Cyngor Cymuned fel aelod o Gorff Llywodraethol yr ysgol leol ac wedi bod yn aelod yn y gorffennol fel rhiant-lywodraethwr. Mae'n flaenor yng Nghapel Cefn ac yn aelod o Gôr Meibion Llangwm.

Mae Prys wedi byw yn ardal Uwchaled trwy gydol ei fywyd. Yn ystod ei yrfa mae wedi gweithio fel gyrrwr lori i gwmni cludiant masnachol ac amaethyddol, wedi ffermio mewn partneriaeth am dros ugain mlynedd ac ers dros deunaw mlynedd yn gweithio yn ffatri trelars Ifor Williams.

DOUG TIDSWELL

Mae Doug a'i deulu wedi ymgartrefu yn Nantglyn ers oddeutu 12 mlynedd bellach, gan chwarae rhan weithgar mewn sawl gweithgaredd cymunedol fel y grŵp drama a grŵp celf a chrefft. Mae hefyd ynglhwm â'r Grŵp Gweithgareddau Gwledig sy'n trefnu oddeutu 6 digwyddiad pob blwyddyn ar gyfer trigolion ein cymuned a'r fro. Mae Doug yn Ymddiriedolwr ar bwylgor fferm wynt Arian Gwynt ers 7 mlynedd bellach ac yn drysorydd arno ers 2 flynedd.

PRYS ELLIS

Prys has been a member of Cerrigydudion Community Council since over a quarter of a century and has chaired the Council's meetings on several occasions. He also represents the Community Council as a member of the local school's Governing Body and was also parent-councillor on the board at one time. He is a Leader of Capel Cefn and a member of Llangwm's Male Voice Choir.

Prys has lived in the Uwchaled area all his life. Throughout his career he has worked as a lorry driver for an Agricultural and Commercial Haulage Company, has farmed in partnership for over twenty years and has worked in Ifor Williams trailers' factory for over eighteen years.

DOUG TIDSWELL

Doug and his family have been residents in the village of Nantglyn for some 12 years, playing an active part in many community activities including the drama group, arts and craft group and he is also involved with the Rural Activities Group who arrange approximately 6 events each year for all residents of the community and the wider area. Doug is currently a Trustee of the Arian Gwynt Wind Farm committee and has been for some 7 years, including 2 years as treasurer.

Mae Doug yn Dirfesurydd Adeiladau Siartredig a Rheolwr Prosiect sy'n meddu ar 40 mlynedd o brofiad yn y maes. Bu hefyd ynghlwm â cheisiadau am gyllid gyda'r Loteri Genedlaethol yn y gorffennol gan ofalu bod y ceisiadau'n bodloni'r meini prawf penodol a bod systemau rheoli llym mewn lle er mwyn sicrhau gwariant priodol.

Doug is a Chartered Building Surveyor and Project Manager with 40 years of experience in this profession. He has also been involved with National Lottery funding submissions in the past, ensuring the set criteria for applications are met and rigorous control systems are in place to ensure appropriate spending.

GERAINT LLOYD

Mae Geraint wedi byw yn Nantglyn ers 1977 a chyn hynny yn byw yn Ninbych ac wedi bod yn cadw diadell o 200 o ddefaid yn ogystal a gweithio'n llawn amser. Mae Geraint yn drysorydd Sioe Nantglyn a Cneifio Cyflym Hiraethog ac yn archwilio llyfrau Ysgolion lleol yn flynyddol. Mae hefyd yn flaenor yng Nghapel Peniel a tra roedd Ysgol Gynradd Nantglyn mewn bodolaeth yn Gadeirydd y Llywodraethwyr yno. Mae Geraint wedi ymddeol o waith llawn amser fel Rheolwr Cyllid yn y Gwasanaeth Prawf Gogledd Cymru ers rhai blynnyddoedd bellach ond yn dal i weithio rhan amser gyda busnesau bach lleol.

GERAINT LLOYD

Geraint has lived in Nantglyn since 1977 and resided in Denbigh before then. He keeps a flock of 200 sheep and works full time. Geraint is a treasurer for Sioe Nantglyn and Hiraethog Speed Shearing and also audits local Schools' books annually. He is also a Leader in Capel Peniel and whilst Nantglyn Primary School was still open he was Chairman of the School Councillor's Board. Geraint retired from his full time post as a Finance Manager in the North Wales Probation Service a few years back but continues to work part time with small local businesses.



ELERI ROBERTS

Mae Eleri yn wreiddiol o Bentrefoelas a bu'n gweithio i Ffermwyr Ifanc Clwyd fel eu Trefnydd Sirol gan gynnal y gweithgareddau sirol a chadw trefn ar y 12 clwb. Mae Helen yn Gydlynnydd Grantiau ar ran Cronfa Budd Cymunedol Brenig Wind Ltd. Bu hi'n gweithio fel swyddog prosiect i Cadwyn Clwyd ers 1999 gan gyfrannu tuag at amrywiaeth eang o brosiectau economaidd a datblygu cymunedol dros y blynnyddoedd. Bu'r ymgynghoriad yn canolbwytio ar y canlynol:

- Barn y gymuned am yr ardal a'u syniadau ynghylch beth ddylid ei newid neu ei wella yn yr ardal
- Safbwyt y gymuned o ardal o fudd y grant
- Safbwyt yr ymatebwyr ynghylch trothwyon y grant
- Adborth ynghylch y rhai hynny ddylai fod yn gymwys i geisio am y gronfa
- Blaenoriaethau'r gronfa
- Aelodaeth a maint y Panel Grantiau

I gyflawni hyn oll, bu i Cadwyn Clwyd gynnal digwyddiadau galw heibio i'r gymuned, un yn Henllan ar Dachwedd y 27ain 2018 ac un arall yng Nghlawdd Newydd ar Dachwedd y 26ain 2018. Roedd y ddua ddigwyddiad o dan eu sang gyda dros 120 o bobl yn bresennol yn ymddynt nhw.

Bu hefyd holiadur ar-lein lle bu i 261 ymateb iddo a mynchyu'r sesiynau galw heibio. Cyflwynodd Cadwyn Clwyd adroddiad ymgynghori i Brenig Wind Ltd ac yn sgil adborth y gymuned fe aeth Cadwyn Clwyd ati i lunio mein prawf y gronfa.

Cadwyn Clwyd undertook a rigorous and fully bilingual consultation process towards the end of 2018 which informed the establishment of the fund. The consultation process was widely publicised through a press release and subsequent press coverage in the Daily Post, Denbighshire Free Press and online news sources. Posters were distributed throughout the area, and information was widely shared on Cadwyn Clwyd social media and partner organisations social media. The consultation focused on the following:

- The community's opinion of the area and their ideas on the things that should be changed or improved about the area
- The community's views of the area of benefit of the grant
- Respondents views about the grant thresholds
- Feedback on who should be eligible to apply for the fund
- The priorities of the fund
- Membership and size of the Grants Panel

To achieve this, Cadwyn Clwyd held drop in events open to the community, one in Henllan on 27th November 2018 and another in Clawdd Newydd on 26th November 2018. Both events were well attended with over 120 present.

An online questionnaire which resulted in a total of 261 responses to the questionnaire and attended the drop-in sessions. Cadwyn Clwyd provided a consultation report to Brenig Wind Ltd and subsequently drew up the fund criteria based on the community feedback.

Yn ystod y 12 mis diwethaf, bu i Cadwyn Clwyd gynnal pedwar digwyddiad galw heibio yn ymwneud â chyllid er mwyn cynnig cyngor ac arweiniad i grwpiau sy'n dymuno elwa o'r gronfa. Roedd y digwyddiadau yn llwyddiant ysgubol gyda dros 200 o bobl yn mynchu'r pedwar digwyddiad. Bu tri digwyddiad yng Nghanolfan Dŵr Cymru, Llyn Brenig ac un yng Nghanolfan Bro Aled, Llansannan.

The fund was launched in September 2019 with a rigorous campaign to engage with the local community about the fund and its opportunities.

Engagement with the community was done through Cadwyn Clwyd officers and the two local authority support officers. Officers have advised and assisted groups to access Brenig Wind Ltd funds, and also directed and supported them to other sources of match funding and additional funds where appropriate. During the last 12 months, Cadwyn Clwyd held four funding drop-in events to provide advice and guidance to groups wishing to benefit from the fund. These were well attended with over 200 people attending the four events. Events were held at: Canolfan Dŵr Cymru, Llyn Brenig and Canolfan Bro Aled, Llansannan.







Number of projects by community council area





To date, three funding rounds have been held:

Round 1 – October 2019
Round 2 – February 2020
Round 3 – August 2020

The Fund has generated a great deal of interest and as such, the fund is heavily oversubscribed with over £1.5million in application values having been received for an available fund of £267,872 for round 1, 2 and 3.

As part of the annual reporting, Cadwyn Clwyd has commissioned its appointed accountant, Jones and Graham Accountants in Denbigh, to undertake an independent examination of the project's finances on an annual basis. The report is included in Appendix A.
