

---

Mae cronfa Budd Cymunedol Brenig bellach yn ei thrydedd flwyddyn. Ers ei lansio mae Cronfa Budd Cymunedol Brenig Wind Ltd wedi helpu prosiectau ar draws ei faes budd yn uniongyrchol. Mae'n gyfle gwych i gymunedau gwledig elwa. Mae Cadwyn Clwyd, gweinyddwr y gronfa leol, eisoes wedi dyfarnu ymhell dros £470,000 i dros 76 o brosiectau lleol gwahanol mewn saith rownd o gyllid i grwpiau cymunedol ar gyfer ystod o brosiectau gwahanol ac wedi eu helpu i drosoli hyd yn oed mwy.

Rydym yn falch o weld ehangder ac ansawdd y prosiectau cymunedol a gefnogir gan Brenig, a'r effaith gadarnhaol ar y cymunedau hynny.

The Brenig Community Benefit fund is now in its third year. Since its launch the Brenig Wind Ltd Community Benefit Fund has directly helped projects across its area of benefit. It's a fantastic opportunity for rural communities to benefit. Cadwyn Clwyd, the local fund administrator, has already awarded well over £470,000 to over 76 different local projects in seven rounds of funding to community groups for a range of different projects and helped them leverage even more.

We're pleased to see the breadth and quality of community projects supported by Brenig, and the positive impact on those communities.

# CYFLWYNIAD INTRODUCTION

Mae Brenig Wind Ltd wedi'w leoli yn ardal Cyngor Cymuned Nantglyn, a ward etholiadol Llanrhaeadr yng Nghinmeirch o fewn Cyngor Sir Ddinbych.

Mae Brenig Wind Ltd yn cynnig cronfa budd cymunedol gwerth bron i £4 miliwn dros gyfnod o 25 mlynedd ac mae modd i gymunedau sy'n amgylchynu'r fferm wynt fanteisio arni. Mae'r fferm wynt, sy'n eiddo i Brenig Wind Ltd, yn weithredol ers Mawrth 2019 a chanddo 16 tyrbin sy'n cynhyrchu 2.35MW. Mae cyfanswm capaciti ynni wedi'i osod yn 37.6MW – sy'n ddigon i gynnal dros 30,000 o dai pob blwyddyn. Caiff y gronfa ei dyrannu i fentrau a phrosiectau cymunedol.

Caiff y gronfa ei gweinyddu gan Cadwyn Clwyd a Phanel Brenig Wind Ltd sy'n gyfrifol am yr holl benderfyniadau yngylch sut caiff y cyllid ei ddyfarnu. Ymystg aelodau'r Panel mae:

Brenig Wind Limited is located in the Community Council area of Nantglyn and the electoral ward of Llanrhaeadr yng Nghinmeirch within Denbighshire County Council.

Brenig Wind Ltd provides a community benefit fund of almost £4 million over 25 years and is available for communities surrounding the windfarm. The windfarm owned by Brenig Wind Ltd became operational in March 2019 and has 16 turbines each of 2.35MW, giving a total installed capacity of 37.6MW – enough to power over 30,000 homes every year. The fund is distributed to local community projects and initiatives.

The fund is administered by Cadwyn Clwyd, all decisions on how funds are awarded are made by the Brenig Wind Ltd Panel. The Panel members are:

# TROSOLWG O'R 12 MIS DIWETHAF

## OVERVIEW OF THE LAST 12 MONTHS

Mae'r gronfa yn darparu cyfanswm o £163,662 y flwyddyn yn gysylltiedig â mynegai dros 25 mlynedd ar gyfer y gronfa budd cymunedol gan gynnwys ei weinyddiaeth. Yn ystod y 12 mis diwethaf, mae rownd 6 a rownd 7 wedi cael eu lawnsio gyda cyfanswm o £113,906.08 wedi'w ddynodi i'r grwpiau.

The fund provides a total of £163,662 per annum index linked over 25 years for the community benefit fund including its administration. During the last 12 months, round 6 and round 7 of the fund was launched with a total of £113,906.08 awarded to groups.

# YMGYSYLLTU Â'R GYMUNED, MARCHNATA A CHYFATHREBU COMMUNITY ENGAGEMENT, MARKETING AND COMMUNICATIONS

Mae Cadwyn Clwyd a'i sefydliadau partner yn parhau i ymgysylltu gyda'r gymuned leol ynglyn a datblygiad prosiectau. Mae Cadwyn Clwyd yn gweithio'n agos gyda Swyddogion Datblygiad Cymunedol Awdurdodau Lleol yn Sir Ddinbych a Sir Conwy i gefnogi cymunedau i ddatblygu prosiectau ac ymgeisio am arian Brenig yn ogystal a helpu i adnabod a dod o hyd i arian cyfatebol. Golygai hyn cafodd £334,000 o arian ychwanegol ei ddarparu.

Yn ystod y 12 mis diwethaf, mae Cadwyn Clwyd wedi cynnal pedwar sesiwn galw-heibio er mwyn darparu cyngor ac arweiniaeth i grwpiau sydd yn bwriadu gwneud cais i Gronfa Brenig. Cafodd rhain eu cynnal yn mis Tachwedd / Rhagfyr 2021 ac Ebrill 2022 a oedd yn boblogaidd iawn gyda dros 20 grŵp yn derbyn cyngor.

Mewn partneriaeth gyda chymdeithion Cadwyn Clwyd, mae Ceidiog Communications wedi creu ymgrych barhaus i'r wasg gyda datganiadau i'r wasg yn hyrwyddo cyllid a ddyfarnwyd, y cyfleoedd sydd yn cael eu cynnig gan y gronfa gyda Clwb Hedfan yn Uchel yn Sir Ddinbych a Beiciau Trydan Hiraethog fel engrifftiau o'r rhai o brosiectau a wnaeth dderbyn cymorth.

Mae cyfathrebiad pellach wedi cael ei gyflawni drwy gyfryngau cymdeithasol a gwefan Cadwyn Clwyd, o'r ymgynghoriad, y ddua rownd ariannu, prosiectau oedd wedi derbyn cyllid a straeon newyddion da. Mae pob rownd cyllido wedi cael ei gyfathrebu drwy ebyst uniongyrchol i gynhorwyr cymuned, grwpiau cymunedol, sefydliadau partner a rhanddeiliad.



Cadwyn Clwyd and its partner organisations continue to engage with the local community in the development of projects. Cadwyn Clwyd works closely with Local Authority Community Development Officers in both Denbighshire CC and Conwy CBC to support communities to develop projects and apply for Brenig funds, as well as assisting to identify and lever match funding. This resulted in £334,000 additional funds being levered.

During the last 12 months, Cadwyn Clwyd has held four funding drop in events to provide advice and guidance to groups wishing to apply for Brenig funds. These were held in November / December 2021 and April 2022 and were well attended with over 20 groups receiving advice.

In partnership with Cadwyn Clwyd's associates - Ceidiog Communications - an on-going press campaign has been undertaken with press releases highlighting the funding awarded, the opportunities offered by the fund, with both Flying High in Denbighshire and Hiraethog Electric Bikes were highlighted as projects receiving support.

Further communication has been undertaken through Cadwyn Clwyd's social media and website to highlight the consultation, all 2 funding rounds, projects awarded grants and good news stories. All funding rounds have been communicated via direct emails to community councils, community groups, partner organisations and stakeholders.






## Gwerth y prosiectau yn ôl ardaloedd Cyngor Cymuned / Value of projects by Community Council


